Program Spotlight: Healthy Families Support Workers Help Young Families Thrive

Last month, our Healthy Families Program Manager, Jeanne Mitchler-Fiks, spent a day with Prevent Child Abuse Virginia (PCAV) at the Virginia State Legislature advocating for funding to improve child health and strengthen families. "UCM's program results are well above expectations," Jeanne told the legislators. "For example, the mothers in our program consistently keep their prenatal doctor appointments.

"This prevents premature births, which are known to result in an additional \$15,000 in medical costs, so there's a measure of positive economic impact in addition to the emotional support provided by our home visits."

Every year, our Family Support Workers (FSWs) provide positive parenting advice during ongoing home visits to 150+ pregnant women and first-time parents. UCM's program is affiliated with Healthy Families America, a nationally accredited program to prevent child abuse and neglect.

At-risk families in our area are referred to UCM's program, typically by the Fairfax County Health Department, regardless of living situation or income level. Our trained, caring FSWs educate parents about positive child-parent interactions and healthy child-rearing practices, screen children for developmental delays, assess the home environment for potential risks, help

families develop goals, and refer parents to available community resources and services.

"We know 93% of the young children in our program are fully immunized, much higher than the state average," Jeanne continues. "This is just one example of how Healthy Families Improves public health and the quality of life for everyone in our community."

Healthy Families Fairfax is just one program in UCM's continuum of services that help families thrive, which also includes our Early Learning Center and after-school programs.
