## UCM Volunteer Agreement and Release

I agree and understand that my primary job duties take precedent over any volunteer assignment, thus, all volunteer work will be conducted outside of my normal work (school) hours at United Community Ministries, Inc.

I agree to familiarize myself with, and abide by, United Community Ministries, Inc.'s rules and policies regarding personal conduct, ethics, confidentiality, and safety and that I will follow the directions and guidance of my supervisor during my volunteer assignment.

I understand that I will be subject to the organization's screening process for volunteers and my retention as a volunteer will depend on my satisfactory completion of the volunteer screening and placement process.

If my duties include driving on United Community Ministries, Inc.'s business, I understand that I must possess a valid driver's license, possess a current auto insurance policy and provide verification with an Identification Card, and that I will be subject to a Department of Motor Vehicle record check.

I understand that United Community Ministries, Inc. provides limited accidental liability coverage to volunteers, but that no other employee, or volunteer sponsored medical, or insurance plans apply to this volunteer assignment.

I understand that I am not covered by United Community Ministries, Inc.'s workers' compensation policy in connection with my volunteer assignment.

I understand that my participation in the volunteer assignment is not in exchange for any consideration (e.g., pay, benefits, or promise of future employment). I acknowledge that, in exchange for my services as a volunteer, I have neither been promised any consideration nor do I expect to receive any consideration or future employment.

I understand that I must participate in an orientation and volunteer training program in order to serve as a volunteer at United Community Ministries, Inc.

I understand that this release discharges United Community Ministries, Inc. from any liability or claim that the volunteer may have against United Community Ministries, Inc. with respect to any bodily injury, personal injury, illness, death, or property damage that may result from the volunteer's activities with United Community Ministries, Inc., whether caused by the negligence of United Community Ministries, Inc. or its officers, directors, employees or agents or otherwise. United Community Ministries, Inc. does not assume any responsibility or obligation to provide financial assistance, or other assistance, including but not limited to medical, health or disability insurance in the event of injury or illness.

I understand that United Community Ministries, Inc. or I may end my volunteer appointment at any time for any reason without advance notice.
